Greg Mutz '67 announced as Class Speaker



Gregory T. Mutz is the Chairman and CEO of AMLI Residential Partners, LLC; a Chicago based real estate company he co-founded in 1980 that was originally named AMLI Realty Co. In 1993, AMLI Realty split into two companies – AMLI Residential Properties Trust and AMLI Commercial Properties Trust. AMLI Residential Properties Trust became a public company in 1994 (NYSE:AML). AMLI Commercial Property Trust was financed as a private REIT by a number

of institutional capital sources, and in 2001 was acquired by a JV between CalPERS and Panattoni Development Company. In 2006, AMLI Residential was acquired by PRIME Property Fund, an institutional core real estate fund managed by Morgan Stanley Real Estate.

Greg was an officer with White, Weld & Co., a New York-based investment banking firm (1976-78), and associated with Mayer Brown (1973-76), a Chicago-based international law firm. He received a B.A. degree from DePauw University in 1967, served in Vietnam as an Infantry Lieutenant (1968-69), and a J.D. degree from the University of Michigan Law School in 1973.

As a DePauw student, Greg was a member of Phi Delta Theta Fraternity, Student Government, and was a premier swimmer, earning over 360 points during four years of varsity competition. During that time he set 13 school records, five pool records, and six Indiana Collegiate Conference marks. He was three times the team's MVP, gaining NCAA All-American honors in 1966-67.

50th Reunion Class Headquarters and Lodging: Humbert Hall

Humbert Hall will serve as the Class of 1967 headquarters and lodging space for our 50th reunion. For those classmates who are planning to stay in Humbert Hall, we've included some helpful lodging information below.

General Information

- Complimentary water, soft drinks, coffee and protein bars are available in the lobby of Humbert Hall to all members/guests of the Class of 1967 through the duration of our stay.
- All rooms have a closet (or wardrobe), at least one single bed, a desk, a chair, a dresser and a bookshelf for each guest. Residence hall rooms are carpeted and also have blinds.
- Linens, pillows and wastebaskets will be provided; however, we encourage you to bring any items that will ensure your stay is comfortable (i.e. extra blanket, pillow, sweatshirt, socks, etc). The dorm rooms can get rather chilly at night, so be sure to pack accordingly.
- Televisions and computers are not provided, but wireless access is available if you wish to bring a smartphone, laptop, or tablet device.
- There are separate community bathrooms for both men and women on each floor.

- Alarm Clock

Join us at ARW for a special presentation by Thomas R. Schuck '72, a partner in the law firm of Taft Stettinius & Hollister LLP in Cincinnati, Ohio. After graduating from DePauw with a degree in English and history, Tom received an M.A. from the University of Kent in Canterbury, England, as a Rotary International Fellow. He then went on to earn a law degree from Harvard University.

Tom's career as an attorney has been marked by numerous accomplishments and honors. Returning to DePauw this summer for his own 45th reunion, he has graciously agreed to discuss estate planning with fellow alumni at a lunch session on Saturday, June 10th.

Specifically, Tom will discuss the many ways in which estate plans can fail to meet their objectives. "You should know that if you do not plan or your plans go awry," he points out, "the state will determine what happens to your assets after your death."

"Careful planning will help avoid unintended consequences with your estate," Tom adds. This luncheon presentation promises to be a thought-provoking exploration of how to fine-tune estate planning for the sake of our heirs and of the charities we hope to support.

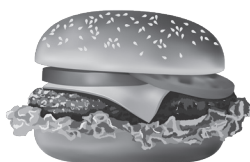
Join the DePauw Legacy Society
