

Request for Less than Full-Time Enrollment

Immigration law requires degree-seeking international students to be enrolled full-time during each academic semester. Under certain specific conditions listed below, the regulations allow students to temporary drop below full-time course load and continue to maintain status. The regulations are strict and allow this as a rare occurrence during the student's program.

Students must meet with their Major/Academic advisor to discuss and fill out this Request to reduce their semester course load to less than full-time (less than 3.0 DePauw credits) **before** adjusting their class schedules.

Upon receiving this form, *International Student Affairs* will complete the necessary administrative request in the Student and Exchange Visitor System (SEVIS) to authorize the reduction in course load.
