Minutes from previous meeting approved

Looked at 2 new course proposals. In the case of Religion 150, a question was raised about the applicants desire to make it a group 4 as it seemed to make more sense being a group 3. The decision was made to get feedback from the department in the form of the rationale for designating the course as group 4. The committee granted course approval with the provisional agreement of the department that the course fulfill group 3. Otherwise, further discussion will take place. In the case of Religion 267, approval was granted with group 4 designation. Discussion of changes to the green "Proposed Departmental Course Change Form." Will request Ken Kirkpatrick place the new form on the web with the legitimate title, followed by a 24 character title, and a 75 word course description. The form could be submitted by department chairs using a special code as a signature. Include a question regarding the group the course will court for; a zero can designate no group. The new order of the questions will be #6, #7, #8, #9 and # 13 of the old green sheet. Concerns about signature and department approval will be discussed after Ken makes mockup of web form.

A vote was taken on the calendar for 200809 academic year. Draft B was chosen. For the academic probation changes, Jeff Hollander suggested mentioning the fact that students pursuing a Bachelor's in Music don't have to select major in the same timeframe as other students. Suggestion was made to change the GPA cutoff for academic probation from 1.1 to 1.3. Next meeting will be Monday September 27, 2004.

The minutes from the 2/14 meeting were unanimously approved.

We discussed several changes to courses in the School of Music: Converting Music 111, 112, and 211 (Theory and Musicianship I, II, and III) each into 2, ¹/₂credit courses. Music 111, 112, and 211 are currently 1credit courses offered for Group 3 credit. Music 113: Theory I (0.5 credit, Group 3) Music 114: Theory II (0.5 credit, Group 3) Music 213: Theory III (0.5 credit, Group 3) Music 123: Musicianship I (0.5 credit, Group 3) Music 124: Musicianship II (0.5 credit, Group 3) Music 223: Musicianship III (0.5 credit, Group 3)

Changing Music 316: Advanced Musicianship to Music 224: Musicianship IV, retaining Group 3 designation.

Changing Music 317: Form and Analysis to Music 214: Theory IV, retaining Group 3 designation.

The committee brought up numerous questions regarding the need to revise course numbers, need to avoid using the same course number for two different courses, phasedin implementation, and concerns about the number of upperlevel courses in the music major for

CLA students. These questions were adequately addressed by Scott Spiegelberg and the committee voted to approve the proposed changes.

Kirkpatrick raised another item related to the School of Music. Current guidelines limit CLA students to obtaining credit for graduation (or for distribution requirements) from one major and one chamber ensemble per semester. This is very difficult to monitor in the Registrar's office. Is this regulation necessary? Should we eliminate the restriction on size of group and simplify it to refer to 2, 0.25 ensemble credits per semester? After some debate, decided we needed to check with the School of Music before proceeding.

Hollander reported on the status of applications for independently designed internships. Three applications are complete. The subcommittee (Hollander, Kirkpatrick, Bordt) will meet on March 1 to consider them.

Hollander asked for volunteers to serve on the 5thyear internship applications committee. Villinski and Balensuela will join him in evaluating the applications.

We are still waiting for clarification on the impact of Chemistry's proposed changes on the chemistry minor.

The committee decided to respond to COA's request that we streamline faculty meetings by changing the process for approving minor course changes. The committee favors such a revision of the process but feels strongly that the proposal should come to the faculty from COA, and not from MAO. We will suggest that COA and MAO discuss changes together. We approved a proposal from the mathematics department to approve Math 141: Statistical Reasoning for group 1 credit. A question was raised about why more mathematics courses have not been brought forward for group credit.

We approved a change to ARTS 398: Studio Art Topics from 1 credit to $\frac{1}{2}$ 1 credit. This detail was omitted in recent changes to the course.

Kirkpatrick noted that items left on the table at December's faculty meeting needed to brought off the table and approved at the next meeting.
