Also, several of our school sites allow students to work with technologies such as SmartBoards and K-12 student laptops. Students are required to utilize the Moodle program. Moodle is a Course Management System (CMS), also known as a Learning Management System (LMS) or a Virtual Learning Environment (VLE). Students are required by the university to possess a laptop upon admissions to DPU. Student teaching and field experience classrooms are often equipped with smartboards and advanced projection technology.
