Through multiple courses and clinical experiences, students meet these assurances. These include MUS 263 (Music for Students with Diverse Needs), MUS 451 (Student Teaching in Music), MUS 452 (Senior Seminar for Music Educators), and clinical experiences in both urban and rural settings. The DePauw Music Teacher Education Program (MTEP) has established minimum criteria for diversity of clinical placements that every MTEP student must meet. All MTEP students have four separate 10-week field experience placements and one 3-week internship. Over the course of these five placements, which are completed prior to student teaching, the following criteria for clinical settings are met by each MTEP student: 1) >10% special education population, 2) >5% English Language Learners (ELL), 3) >33% non-white population, and 4) >33% Free/Reduced Lunch.

The DePauw Music Teacher Education Program (MTEP) has incorporated the International Society for Technology in Education (ISTE) Standards for Educators into its curriculum. The ISTE standards are addressed multiple times in MTEP courses; however, each standard is specifically addressed and assessed in specific courses as follows. Standard 1, Learner, is addressed in MUS 255, Instrumental and Choral Music Education Lab. MTEP students enroll in this course three times, as a first-year student, sophomore, and junior. Standard 1 is addressed and assessed with the first-year students by the completion of a project. Students design a presentation for fellow classmates that meets at least one of the components of the ISTE Learner standard. The presentation should contain access to useful resources for educators. Students share the presentation via a Moodle module. (DePauw uses Moodle as its learning management system.) Standard 2, Leader, is addressed in MUS 352, Secondary Vocal Music: Methods, Materials and Curricula, a class for vocal students, and in MUS 354, Elementary and Secondary Instrumental Music: Methods, Materials, and Curricula, a class for instrumental students. This standard is currently addressed and assessed via an assignment. Students collect resources on a topic related to the successful implementation of a choral or instrumental program, create an online presentation about the chosen topic, and upload both to their professional websites. Standard 3, Citizen, is addressed in MUS 355, Secondary General Music: Methods, Materials, and Curricula. This standard is currently addressed and assessed via the completion of an assignment. Students design a technology lesson for use in a secondary general music classroom. The lesson is to focus on developing secondary general music students' ability to "positively contribute to and responsibly participate in the

digital world." Standard 4, Collaborator, will be addressed in MUS 263, Music for Students with Diverse Needs. This course is offered on a three-semester rotation and is scheduled for Fall 2020. At this time, the details of the assignment are in the planning stages. Standard 5, Designer, is addressed in MUS 255, Instrumental and Choral Music Education Lab. MTEP students enroll in this course three times, as a first-year student, sophomore, and junior. Standard 5 is addressed and assessed with the sophomores via an assignment. Students design a lesson that involves the use of technology to meet at least one of the three components of the standard. Possible examples include using technology to differentiate/foster independent learning, setting up video/graphic prompts in an engaging presentation format to remind students about correct performance technique in a warm-up, and creating a digital assignment to develop students' understanding of musical concepts related to ensemble literature. Standard 6, Facilitator, will be addressed in MUS 351, Elementary General Music: Methods, Materials, and Curricula. This course is offered every other year and is scheduled for Fall 2020. The details of the assignment are in the planning stages. Standard 7, Analyst, is addressed in MUS 255, Instrumental and Choral Music Education Lab. MTEP students enroll in this course three times, as a first-year student, sophomore, and junior. Standard 7 is addressed and assessed with the juniors via an assignment. Students design a system of collecting and communicating assessment data to P-12 learners that utilizes technology. The assessment data is to be used when planning rehearsals and designing differentiation methods. Differentiation methods must reference all learners in a concrete way. The impact of assessment data on instruction is to be clearly referenced in all lesson/rehearsal plans. Other ways in which MTEP students are prepared to integrate technology effectively into curricula and instruction, and to use technology effectively to collect, manage, and analyze data in order to improve teaching and learning for the purpose of increasing student academic achievement include using and evaluating digital music curricula, arranging developmentally appropriate music using music notation software (such as Finale or Sibelius), demonstrating proficiency in the use of video technology by creating developmentally appropriate instructional videos for use by P-12 music students and uploading them to their professional websites as well as recording and uploading videos for peer and instructor evaluation, using technology effectively to collect, manage, and analyze P-12 student data during the implementation of a multi-week unit during student teaching, and attending a DePauw Music Education Professional Learning Community Workshop, presented by one or more in-service music teachers, on the topic of technology. In addition to these measures, MTEP students are prepared to use the principles of universal design for learning in MUS 263, Music for Students with Diverse Needs, and MUS 355, Secondary General Music: Methods, Materials, and Curricula.

## Teacher Training

#### a. Teach students with disabilities effectively

Through readings, assignments, activities and field work for MUS 263, Music for Students with Diverse Needs, MTEP students are thoroughly prepared to effectively teach students with disabilities. Though diversity, inclusion, differentiation, and other relevant topics are addressed throughout the MTEP curriculum, MUS 263 is the course devoted entirely to preparing pre-service music educators to effectively teach students with disabilities. The MUS 263 Course Objectives include the following: respect and appreciate diversity; examine personal assumptions and stereotypes of people who are different from themselves; develop a language to discourse about differences; expand understandings of diversity and its relevance to achievement; understand the impact of legislation and educational policy on students with diverse needs; identify teaching practices that include and exclude students who are different; gain an awareness of student capabilities and educational challenges through observation of and interactions with individuals with diverse needs; demonstrate an understanding of diversity by responding appropriately according to individual needs; design standards-based instructional music lessons to reach all learners; select assessment tools for measuring student progress in learning; and, apply positive behavioral supports and interventions to address student and classroom management needs. Relevant course topics in MUS 263, Music for Students with Diverse Needs, include the following: overview and history of special education; special education procedures, policies, and processes; Individualized Education Programs (IEP); inclusive principles and practices; teaching strategies for successful inclusion; accommodations and assistive technologies; music education service delivery options; Response to Intervention (RTI); Universal Design for Learning (UDL); and assessment of learner progress.

#### b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

MTEP students learn about the Individuals with Disabilities Education Act (IDEA) and individualized education programs (IEPs) as well as how they will participate as members of IEP teams in multiple courses. The course that most extensively prepares students for this responsibility is MUS 263, Music for Students with Diverse Needs.

#### c. Effectively teach students who are limited English proficient.

MTEP students learn strategies for teaching students who are limited English proficient in MUS 263, Music for Students with Diverse Needs. In addition to completing relevant readings and assignments, and participating in a session with a WIDA-trained guest speaker, all MTEP students observe a WIDA-trained teacher in a class with English Language Learners and complete a project based on this observation. MTEP students gain experience working with students who are limited English proficient in at least one of their five field experience placements. The MTEP has established a minimum criteria that all students must meet to ensure diversity of field placements. One criterion is that the school must have an enrollment of English Language Learners that is greater than five percent.
